We don't want to raise alarm or suggest this applies to all pupils but as part of our focus on keeping children safe, the following disturbing information emerged.

We have been informed by some children that they are regularly

- ♦ Taking part in online gaming involving "18" rated videos like Call of Duty and Grand Theft Auto which has potentially disturbing content
- ♦ Interacting with Social Media platforms such as Snapchat, Facebook, WhatsApp and Instagram and are account holders before they have reached the minimum age limit. The reasons why social media apps have age restrictions (normally 13, 16 or 18) is due to adult advertising that is allowed on their sites and exposure to adult content, as well as non-understanding of privacy settings i.e. allowing the whole world to see you online.
- ♦ Using YouTube for watching (without filtering) and posting their own videos.
- ♦ Discovering other seemingly innocent media such as Music.ly that allows interaction with persons unknown
- ♦ In general, putting themselves at risk and becoming vulnerable through their naivety about the potential dangers of the internet.

As adults in charge of children's safety and well-being, we know we have a great responsibility as parents and teachers.

However, unless we take advice or are constantly updating our own skills and knowledge of the capabilities of the internet, the children will leave us behind and could be exposed to criminal behaviour.

## **IMPORTANT ONLINE SAFETY**

This week we have been discussing online safety as part of the National Safer Internet Day on Tuesday 7<sup>th</sup> February.

We don't want to raise alarm or suggest this applies to all pupils but as part of our focus on keeping children safe, the following disturbing information emerged.

We have been informed by some children that they are regularly

- ♦ Taking part in online gaming involving "18" rated videos like Call of Duty and Grand Theft Auto which has potentially disturbing content
- ♦ Interacting with Social Media platforms such as Snapchat, Facebook, WhatsApp and Instagram and are account holders before they have reached the minimum age limit. The reasons why social media apps have age restrictions (normally 13, 16 or 18) is due to adult advertising that is allowed on their sites and exposure to adult content, as well as non-understanding of privacy settings i.e. allowing the whole world to see you online.
- ♦ Using YouTube for watching (without filtering) and posting their own videos.
- ♦ Discovering other seemingly innocent media such as Music.ly that allows interaction with persons unknown
- ♦ In general, putting themselves at risk and becoming vulnerable through their naivety about the potential dangers of the internet.

As adults in charge of children's safety and well-being, we know we have a great responsibility as parents and teachers.

However, unless we take advice or are constantly updating our own skills and knowledge of the capabilities of the internet, the children will leave us behind and could be exposed to criminal behaviour.
